Terms and conditions

Overview

If you have your natural gas furnace and/or fireplace serviced between May 1, 2011 and October 31, 2011 you may qualify for a \$25 grocery gift card for each (maximum of one card for fireplaces and one card for furnaces, for a total maximum of two cards per FortisBC natural gas account).

Eligible participants

To qualify for gift cards the applicant must be a current FortisBC Energy Inc. or FortisBC Energy (Vancouver Island) Inc. (collectively, "FortisBC") residential natural gas customer. This offer is currently not available in Whistler.

Eligible furnace service

To qualify, the furnace and/or fireplace service must be:

- performed between May 1, 2011 and October 31, 2011
- provided by a BC Safety Authority licensed gas contractor and in accordance with all applicable laws, codes, standards and ordinances

Program process

- To be eligible for a gift card, the applicant must return a copy of the completed application form with a copy of the gas contractor invoice that contains the date of furnace and/or fireplace service, details of the work performed and the BC Safety Authority licence number of the gas contractor.
- Applications must be submitted no later than November 30, 2011.
- Applications must be signed by the applicant.
- Processing of applications may take a minimum of 90 days.
- FortisBC is not responsible for lost, delayed, damaged, illegible or incomplete applications or gift cards.
